

The Quality Improvement Unit (QIU) of the Human Research Protection Program (HRPP) conducted a five-year analysis of total IRB submissions. The IRB submission to approval times have decreased by an average of 23% over the last 5 years. As of January 10, 2024, there are 6,149 active protocols. Over the last 5 years, total HRPP/IRB staff have increased from 17 to 23. Data for this analysis were pulled from iStar for determinations and Human Resources for staffing. **This report reflects initial IRB submission only. It does not include amendments or continuing reviews.**






TOTAL IRB SUBMISSIONS AND HRPP/IRB STAFF COUNT BY YEAR




TOTAL IRB SUBMISSIONS BY DISCIPLINE AND YEAR




TOTAL IRB SUBMISSIONS BY YEAR AND DETERMINATION




TOTAL BIOMEDICAL IRB SUBMISSIONS BY YEAR AND DETERMINATION




TOTAL SOCIAL BEHAVIORAL IRB SUBMISSIONS BY YEAR AND DETERMINATION




